Introduction

For the Strategic Planning project, I chose to study Hubbard Street Dance Company. Hubbard Street meets the characteristics that are required for the project. With my dance background, I am interested in analyzing a dance organization and meeting contacts in the arts field. In this memo, I will describe the organization and explain why it meets the selection rationale

Organization Description

Hubbard Street Dance Company is a nonprofit dance organization based in Chicago. Hubbard Street's mission is to "bring artists, art and audiences together to enrich, engage, educate, transform, and change lives through the experience of dance" (Hubbard Street Dance Chicago, 2015, Company History section). Hubbard Street fulfills this mission through its professional performing companies, dance studio, and community outreach programs.

Selection Rationale

Hubbard Street fits the required agency characteristics. Hubbard Street is located in the West side of Chicago. I have access to three recent contiguous IRS 990 forms. I have included the three 990 forms in the Appendix. Hubbard Street's revenue in the fiscal year 2012-2013 was \$5,657,683. Hubbard Street employs over 30 full-time staff. Hubbard Street had positive net assets of \$7,185,372 in the fiscal year 2012-2013.

Hubbard Street mostly fits the ideal agency selection criteria. I have taken dance classes at the studio and have watched performance videos online. I do not have a contact at the organization, but I would like to use this project as an opportunity to meet staff members. Hubbard Street has a comprehensive website, and I have access to the annual reports.

Summary

Hubbard Street Dance Company meets the selection criteria for the Strategic Planning project. I aspire to work in an arts organization in the future. By analyzing Hubbard Street, I will gain insight into strategizing for an arts nonprofit organization.
